# 2022 WYOMING OPEN STATE BOWLING TOURNAMENT

Two Bar Bowling Center, 700 E. Carlson, Cheyenne, WY 82009 307-634-7918

- 1- Entries close and must be postmarked no later than Monday, March 1, 2022. Rule 310A. Late entries are at the discretion of the tournament manager.
- 2- The Tournament is open to all Wyoming State USBC members and/or Wyoming residents. All entrants must have a Wyoming USBC card. **Cards will be checked at the time of bowling.**
- 3- **AVERAGE:** Bowlers will use their highest sanctioned average with 21 or more games from either 20/21 Season book average (summer or winter)( or mid-season as of 12/31/2021 or 3 years of composite State Championship average with last 5 years, which ever is highest) All other bowlers will bowl scratch. --- No Ten Pin Rule -----
- 4- **Handicap will be 90% of the difference from 235. With No Maximum handicap.**
- 5- It shall be each bowler's responsibility to verify the accuracy of their average for this tournament, whether it was originally submitted by the bowler, team captain, or others. Failure to use the correct average shall result in disqualification.
- 6- Prize winnings shall be based on the submitted average, if it is higher than the actual average.
- 7- Correction in averages must be made by the completion of the effective bowlers first game of the tournament. USBC rules 319 D & E will apply. Rule 319A1. (b) Does not apply
- 8- Cash prizes will be paid for scratch and handicap events. 30% of the prize fund will be used for scratch prizes, and 70% of the prize fund will be used for handicap prizes. Each entrant may win cash in either (not both) handicap or scratch events based on the highest payout. At the ratio of 1/10 in all events except all events. All events will be paid out in the ratio of 1/15.
- 9- Trophies will be awarded to both scratch and handicap winners. The Wyoming State USBGC will reserve one entry for the next **upcoming** USBC Open Tournament for the Scratch All Events Winner, or runner up. Entry will be paid up to \$500 and \$500 towards expenses.
- 10- Entrants may bowl team (2) times. No more than three (3) players shall cash together more than once. Bowl one (1) time in singles and doubles. First score in team, doubles & singles events counts toward "All Events" total.
- 11- To enter Singles & Doubles, you must bowl both events consecutively and will be bowled on same lanes. This is considered one squad. Singles first, Doubles second. Singles and Doubles must enter on the same entry form. Due to Physical Impairment, if a bowler can't bowl more than 3 games at a time, please contact the Tournament Director to make arrangements.
- 12- All bowlers are requested to check in **30 minutes prior to squad time. Bring USBC card to check in if unable to verify with Bowl.com**
- 13- Substitutions for absent bowlers and any changes will be allowed up to 30 minutes prior to squad start time. Do not send in names of replacement bowlers by mail. Replacements will be registered at check-in. Team Captain can call Tournament Director with change. Once you start a series no sub will be allowed in any event.
- 14- No Telephone Reservations will be accepted.
- 15- Unmarried grad and high school students that have not reached the age of 18 by 1/31/21 must have a parental consent form on file with the tournament director prior to bowling.
- 16- Recap sheets will be the official score sheet. Errors must be brought to the attention of the tournament official within 30 minutes after the completion of the event, otherwise all scores will be official. Rule 327c "Loss of Scores" applies.
- 17- Tournament officials may remove a bowler from the lanes due to misconduct or actions that are detrimental to good bowling etiquette. Appropriate non-offensive attire in accordance with USBC's Rules.
- 18- Team captains will be sent a confirmation acknowledging receipt of their entry by marking below: Email-- Web -- Mail
- 19- USBC Rules will apply to anything not covered by these rules.

## SENIOR QUALIFYING

- 1- Entry is open to USBC members who are 50 years of age or older **on or before entry deadline. (rule #1)**
- 2- Entry fee is \$20.00 (prize fund \$11.00 & Expenses \$9.00)
- 3- Divisions will consist of: Age 50-54, 55-59, 60-64, 65-69, 70-74 and 75 and older.
- 4- All prize money will be returned 100% in each division at least 1 for 10. First place winner in each age division will have entry fee paid to the next upcoming National Senior Tournament.
- 5- Tournament will consist of 9 game total. (team, singles, doubles) First score in each event will count.
- 6- Entering average based on above rules.
- 7- Handicap based on above rule #4.
- 8- USBC Rules will apply to anything not covered by these rules.
