Added to Scholarship by Wyoming Bowling Proprietor's Association

1) Participation at the local and state level open to any youth USBC member bowling in a league in a WBPA member center in good standing (cannot bowl just travel league) Both youth and adults must have a current USBC card. Adults: graduating class must have graduated From high school: must have an average in an adult League as per the rule #6.

2) If held, dates for local in-house qualifying will be 10/15/19 to 12/31/19.

3) Entrants may qualify for Class 1 doubles by bowling a local qualifier. If established by a WPBA member center. All others will pay the Class 2 doubles fee. If a local in-house tournament is held the following ratio will be used for teams advancing to state:

One of 3 entrants pay Class 1 fee, other 2 pay Class 2 Fee, based on their scores at the in-house level.

Example: 2 pair = 1 @ \$30: 1 @ \$40

3 pair = 1 @ \$30: 2 @ \$40

4 pair = 2 @ \$30: 2 @ \$40

5 pair = 2 @ \$30: 3 @ \$40

4) State level: Doubles divisions based on the age of Junior bowler on 8/1/19 as follows:

Bantam 8 and under

Prep 9 to 11

Junior 12 to 14

Senior 15 and up

Team is all one (1) division. All Events: separate boys & girls in their own age division.

5) Handicap will be 90% of 240 for both youth and adults.

6) Junior Averages: at state to be used in the following order:

a. Highest current sanctioned league average as of 1/1/20 with a minimum of 21 games.

b. Highest current sanctioned league average as of 1/1/20 with a minimum of 12 games.

c. All other must bowl scratch.

Adults Averages:

a. Highest 2018-2019 sanctioned league final average in an adult league with a minimum of 21 games.

b. Highest current sanctioned league average as of 1/1/20 in and adult league with minimum of 21 games.

c. All other must bowl scratch.

- 7) a. Doubles division (1 junior/1 adult as indicated by age in rule #4.
b. Junior bowlers must bowl doubles to be eligible for team event.
c. Multiple participation is allowed for adults only. Needed adult substitutions should be reported to the tournament director as soon as possible.

8) No absentee scores will be allowed.

9) State entry fee: \$10 per doubles plus:

10) Award fees returned 100% as scholarships to the junior bowler to 1 for every 6 entries in each division. All Events will be scholarships on 1 to 10 ratios.

11) Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or therefrom, fire natural disaster or any other reason beyond the control of the Wyoming Bowling Proprietors Association shall cause, to the extent required thereby, all advertised prizes, guaranteed or otherwise to be pro-rated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.

12) Tournament will be conducted in accordance with the general playing rules of the USBC rules that are relevant will also be in affect. Any rules controversy will be decided by the WBP Tournament Committee, whose decision will be final unless an appeal is made in accordance with rule 329 and 705.

13) No smoking or drinking of alcohol will be allowed in the bowling center by any junior bowler.

14) All entries must come through the Proprietor or Appointed Representative with the master recap sheet. No individual may submit an entry!.
