ENTRY DEADLINE - OCTOBER 1, 2020

1. Open to all Wyoming Youth USBC members, must be attending school and not completed the 12th grade.
2. Limited to the 1st 80 entries.
3. Average:
 - a) 2019-2020 final highest league average including Travel League (minimum of 21 games)
 - b) Current average (minimum of 21 games) This includes the highest average for summer or winter leagues.
 - c) If a, or b, does not apply, you will bowl scratch.
4. Handicap will be based on 70% of 220
5. Entry fee will be \$50 (prize = \$20.00, bowling = \$25.00, expenses = \$5.00)
6. A six game qualifying round will begin at 12:00 Noon on Saturday, October 3rd, 2020 with Masters Divisions and Queens Division.
7. Top 10 bowlers in each Division (Boys/Girls) will qualify for the semi-finals on Sunday at 8:00 a.m., Oct. 4th, 2020 in two divisions (Girls = Queens Division / Boys = Masters Division). Six more games will be bowled, with the total of 6 games qualifying the top 5 championship play.
8. Championship round will be one game pro-style, head to head match play. (qualifier #5 will bowl against #4 with the winner progressing to face #3, etc.)
9. Entrants under the age of 19 should be accompanied by an adult guardian.
10. Entrants must report at least 30 minutes before match begin.
11. All averages must be verified by a local Youth USBC Association Officer or proprietor.
12. Any entry received with incorrect or omitted information or fee will be returned.
13. Ratio will be at least 1 to 10 with top 5 bowlers receiving scholarship in each division.
14. No re-racks will be allowed - if ten pins are standing, it will be considered a legal rack.
15. All other rules shall be governed by Youth USBC guidelines.
16. ENTRIES WILL BE VERIFIED ON THE CAMELANES.COM WEBSITE or call Judy at the number below or Camelanes
17. Prize fund will be returned 100% in scholarship. Money is held by the SMART Program.
18. JUNIOR GOLD QUALIFIER will be ran during this tournament and qualify with scratch games.
 - a) Division are U12, U15, U17 and U20
 - b) Ratio is 1:4 for advancement
 - c) Cost will be \$30 to participate
 - d) Junior Gold Membership Application for 12 and up is \$30 and under 12 is \$10

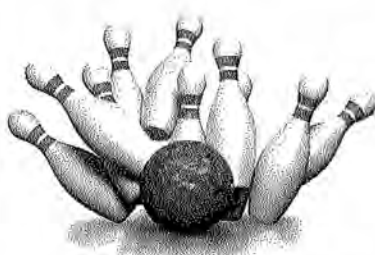
