State Finals will be held April 4-5, 2020 at El Mark O Lanes in Casper.

REGIONAL

1. Team will be comprised of four (4) members: all boys, all girls, or mixed.
2. All USBC Youth members from the State of Wyoming are eligible except those that have graduated from high school or their scheduled graduating class has done so.
3. Handicap will be 90% of 220. Cost will be \$20 per bowler, per session (\$16.50 lineage/\$1.50 expenses/\$2 awards).
4. A pre-registration fee of \$10 per bowler (\$40 per team) and entry required by October 25, 2019.
5. Wyoming Junior Travel League is a guaranteed league with fees required each month from each team member. Bowling fees will be collected at check-in for each monthly session. Regular team member is responsible for substitute fees. Teams may be replaced and forfeit rights to refund if all funds are not paid within one (1) week past the league session. Regions will be determined by preregistrations received by October 25, 2019.
6. Beginning averages will be used in this order
 1. Final travel league average from 2018-2019 with a minimum of 12 games.
 2. Verified final local league average from 2018-2019 with a minimum of 12 games
 3. Current league average as of 1st session with a minimum of 12 games
 4. If none of the above, first three (3) games bowled in 2019 travel league.
7. Four (4) monthly sessions of 6 games each will be held in each region. Averages will be figured between each monthly session but will remain the same for the 6 games of a session. Recommended dates are November 17, December 15, January 19, and February 16.
8. Once teams are formed, teams cannot borrow players from other teams. A sub list will be established and available for any team. Match consists of one (1) game with one (1) point awarded for each individual win and three (3) points for team win for a total of seven (7) possible points.
9. A 24 week league schedule will be used and accumulative point totals will determine area standings.
10. In case of odd numbers of teams, unpaired bowlers must score within 10 pins of their average to be awarded a point. Team must be within 40 pins of the team average to be awarded points.
11. Absentee score will be average minus 10 pins plus handicap (must be used if a bowler is listed on the team).
12. Vacancy average will be 100 plus handicap for that average (only used if team is missing a bowler).
13. Teams on odd(left) lane will set lineup first, then team on even (right) lane will enter theirs - after which lineup may not be modified for that game.
14. Qualifying for state final is based on accumulative points received in the four (4) monthly sessions in each area.
15. Only bowling centers represented by a team in this league will be considered to host a monthly area session.
16. Monthly standing sheets will be sent to the participating houses in the area by area director.
17. Regular members bowling in regional sessions will be awarded 2 points in the State Grand Prix program.
18. In case of a tie for advancing to state finals, the team with the greatest total pins with handicap will be given right of first refusal. The area will be informed of the number advancing from each area proportionate to the number bowling in the area.
18. Awards fees will be returned 100% in scholarships with a ratio of at least 1 to 8.
